Dear Chairman Jagland and Members of the Norwegian Nobel Committee:

We, the undersigned members of the United States Congress, respectfully nominate Dr. Óscar Elías Biscet González for the 2011 Nobel Peace Prize.

Dr. Biscet is a Cuban human rights activist and political prisoner. He is distinguished by his extraordinary vision, courage, leadership, and dedication to non-violence in pursuing human rights for all of the people of Cuba, in stark contrast to the depredations of the Cuban authoritarian regime. Since the 1980s, Dr. Biscet has been active in the defense of human rights, conducting and disseminating studies of rights violations, and organizing peaceful demonstrations, educational efforts, civic projects, and non-governmental organizations.

In 1997, Dr. Biscet founded a new organization in Havana – the Lawton Foundation for Human Rights – with the mission of defending inalienable human rights. The Foundation proposed to the Cuban people a fundamental reform of their political, social, and economic life, to bring their circumstances into accord with the Universal Declaration of Human Rights.

Since that time, Dr. Biscet has pursued his defense of human rights at great risk to himself, and he has paid an extraordinarily high price. In a matter of 18 months, he was arbitrarily detained 26 times. After being arrested and beaten dozens of times by Cuban officials, Dr. Biscet served a three-year prison sentence (from 1999 to 2002) for organizing peaceful political protests. After his October 2002 release, he continued his human rights work, meeting with other dissidents in private homes to promote the “Club for Friends of Human Rights,” a new civic group in which Cubans could meet in small groups to educate themselves about their human rights and nonviolent methods for pursuing them. As a result of his continued advocacy during his thirty-six days of freedom, Cuban secret police seized him on December 6, 2002, and subjected him to months of maltreatment. In April of 2003, the Cuban regime imposed a 25 year prison sentence on Dr. Biscet for spurious “crimes” against state security.


For the last eight years, Dr. Biscet has been held in wretched, life-threatening conditions. He has been confined for many months at a time in a small, windowless cell barely larger than his own body, with no natural light, no plumbing, no reading materials,

and no contact with other inmates. He also has been housed for months in a cell deliberately overcrowded with dozens of inmates, many of them violent and abusive criminals. He has suffered severe weight loss and other illnesses, and has now spent more than a decade in prison, separated from his family. Yet even in prison, Dr. Biscet inspires his fellow prisoners, protests their mistreatment, and sends out messages of encouragement and hope to his fellow Cubans. While other Cuban political prisoners have recently been forced to leave Cuba in exchange for their freedom, Dr. Biscet has made clear that he will not accept release conditioned upon leaving his country, which is tantamount to a forced exile from the Cuban people he has pledged to serve. In his personal sacrifice, Dr. Biscet is a heroic witness to the immutable dignity of the human person.

It is hard to imagine a person who better deserves – or would benefit more from – recognition by the Norwegian Nobel Committee. Dr. Biscet has spent his professional life promoting the fundamental values articulated by the Universal Declaration of Human Rights with a tenacious commitment to principled nonviolence. Honoring Dr. Biscet would not only vindicate his work and personal sacrifice, but also would send a powerful signal of global solidarity with the Cuban people, who aspire to the protection of their fundamental human rights and freedoms.







